operated by Defendants Small Smiles Holding Company, LLC, FORBA Services, Inc. and FORBA Holdings, LLC organized and existing under the laws of the State of Oklahoma with the sole purpose of rendering professional services of dentistry.

Defendants FORBA Holdings, LLC, FORBA Services, Inc., Small Smiles Holding Company, LLC; Small Smiles Holding Company, LLC, d/b/a Small Smiles Dental Clinic of Oklahoma City a/k/a Oklahoma Smiles Dental Clinic of South Oklahoma City a/k/a Children's Dental Clinic of Oklahoma City, PLLC negligently recruited, hired and trained dentist, including Defendants Jimema Poitevien, D.D.S. Ron

Quade, D.D.S.; Douglas Durst, D.D.S.; Erin Heathcock, D.D.S.; Monica Switzer, D.D.S.; Megann Scott, D.D.S.; Giang Binh Pham, D.D.S.; Stephen Cash, D.D.S.; Euna Chang, D.D.S.; Robert Watson, D.D.S.; and Stephen Parker, D.D.S. and/or other employees employed by its clinics.

- 34. Defendants FORBA Holdings, LLC, FORBA Services, Inc., Small Smiles Holding Company, LLC, d/b/a Small Smiles Holding Company, LLC, d/b/a Small Smiles Dental Clinic of Oklahoma City a/k/a Oklahoma Smiles Dental Clinic of South Oklahoma City a/k/a Children's Dental Clinic of Oklahoma City, PLLC threatened and berated its dentists, including Defendants Jimema Poitevien, D.D.S. Ron Quade, D.D.S.; Douglas Durst, D.D.S.; Erin Heathcock, D.D.S.; Monica Switzer, D.D.S.; Megann Scott, D.D.S.; Giang Binh Pham, D.D.S.; Stephen Cash, D.D.S.; Euna Chang, D.D.S.; Robert Watson, D.D.S.; and Stephen Parker, D.D.S. in an effort to increase production which fostered medically unnecessary, substandard dental care.
- 35. Defendants FORBA Holdings, LLC, FORBA Services, Inc., Small Smiles Holding Company, LLC; Small Smiles Holding Company, LLC, d/b/a Small Smiles Dental Clinic of Oklahoma City a/k/a Oklahoma Smiles Dental Clinic of South Oklahoma City a/k/a Children's Dental Clinic of Oklahoma City, PLLC encouraged and promoted the use of physical restraining methods without the benefit of sedation to increase production.
- 36. Defendants' conduct constitutes malicious, oppressive, egregious, and reckless disregard for the safety of children justifying an award of punitive damages in excess of \$75,000.00.
